Anna Southall enjoyed a long and varied career in the cultural sector, initially as a conservator at Tate Gallery, then as Director of the National Museums of Wales and ultimately Chief Executive of MLA, the Museums Libraries and Archives Council.

Since 1975 she has served on the boards of a number of grant making bodies, both independent and in the public sector. She chaired the Barrow Cadbury Trust from 1996 to 2006, and remains their Lead Trustee for the Young Adults and Criminal Justice programme. In 2004 she joined the Board of the fledgling Big Lottery Fund, the largest of the lottery distributors, becoming Vice Chair in 2006 until 2014.

Currently Vice Chair of the Wales Millennium Centre, Anna also serves on the boards of a number of organisations in Bristol where she lives, including Bristol Together (working with ex-offenders) and the Tobacco Factory Theatre.

Thomas lives in Bath, is happily married with two adult sons and spends any spare time pursuing his love of cooking, cycling and Bath Rugby.

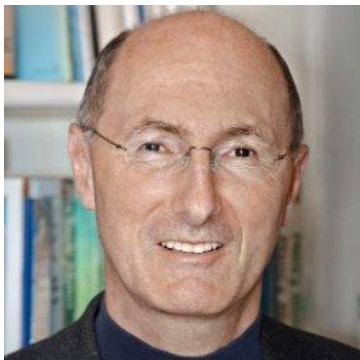
Jim McAuliffe

Upcoming releases include *Mary Magdalene* (starring Rooney Mara and Joaquin Phoenix) and *How to Talk to Girls at Parties* (starring Elle Fanning and Nicole Kidman).

Prior to founding See Saw Films, Canning was executive producer for the critically acclaimed *Hunger* (2008) and *Control* (2007). Canning grew up in Bristol and was an active participant in the film and arts scene and a regular visitor to the Arnolfini.

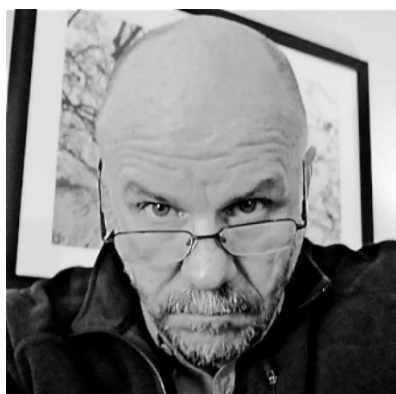
Emmeline Rodman
